All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, in Fairview Township, containing 1.04 A., more or less, according to a plat and survey made by Lewis C. Godsey, Surveyor, in November, 1960, said plat entitled "Property of Ben Garrett, near Fountain Inn, S. C." and having, the following metes and bounds, according to said plat, to-wit:

BEGINNING at an iron pin in the Northern edge of new State Highway No. 418, at the joint front corner with lot of land this day conveyed to Lewis P. Eskew and Mary Sue G. Eskew and running thence with the edge of the right-of-way of said new Highway No. 418, N. 79-35 W., 250.6 ft. to the Eastern edge of the new cut road hereinafter described; thence with the edge of said Road, N. 0-30 W., 156.9 ft. to an iron pin in the edge of said Road and corner with the lot of Ben Garrett; thence with the joint line of Ben Garrett, S. 85-40 E., 247.5 ft. to an iron pin at the joint back corner with lot this day conveyed to the Eskews; thence with the joint line of the Eskews lot, S. 0-30 E., 183.6 ft. to an iron pin at the point of beginning and bounded by new state Highway No. 418, new cut road, Ben Garrett and lot of the Eskews. Also, a road way along western boundary of above described lot with the following metes and bounds, to-wit:

BEGINNING at an iron pin in the Northern edge of New State Highway No. 418 and running thence along the western edge of the above described lot, N. 0-30 W., 156.9 ft. to the joint corner of the above described lot with the property of Ben Garrett; thence S. 85-40 E., 35.1 ft. to an old iron pin; Curry property line; thence with the joint line of Curry, S. 0-30 E., 153.1 ft. to an iron pin in the edge of said new State Highway No. 418; thence along said new Highway, S. 79-35 E., 35.7 ft. to the point of beginning.
