that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the South side of University Ridge, being bounded by property of University Ridge Homes, Inc., other property of the Grantor, and street known as University Ridge and having, according to plat by Pickell and Pickell dated March 23, 1948, the following metes and bounds, to-wit:
