due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgage to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged; has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, lying on the southern side of Chandler Road, containing 75/100ths of an acre and being described according to a survey prepared by John A. Simmons, dated December 15, 1970, as follows:

"BEGINNING at a nail and cap in the center of Chandler Road (sometimes known as Johnson Road) at the corner of property now or formerly owned by Wade and Barbara Tate and running thence with the center of Chandler Road, S. 66-50 E. 200 feet to a nail and cap; thence S. 24-40 E. 216 feet to an iron pin; thence N. 65-20 W. 118.8 feet to an iron pin; thence N. 3-30 E. 226.7 feet to a nail and cap in the center of Chandler Road, the point of beginning; being the same conveyed to us by Robert M. Brown and Paula P. Brown by deed of even date to be recorded herewith."
