

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Donington Drive, being known and designated as Lot No. 25, as shown on an Addition to the Plat of Kingsgate, said Plat of Kingsgate being recorded in the R. M. C. Office for Greenville County, in Plat Book WWW, at Pages 44 and 45, and having, according to said Addition to Plat of Kingsgate, the following metes and bounds, to-wit:

Beginning at an iron pin on the northwestern side of Donington Drive, at the joint front corner of Lots 24 and 25, and running thence along the common line of said Lots N. 32-22 W. 164.98 feet to an iron pin; thence running N. 56-25 E. 119.7 feet to an iron pin at the joint rear corner of Lots 25 and 26; thence with the common line of said Lots S. 32-22 E. 169.7 feet to an iron pin on the northwestern side of Donington Drive; thence with the line of said Donington Drive S. 58-40 W. 120.0 feet to the point of beginning.
