"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot 187, Plat of Section 4, Colonial Hills, which plat is recorded in the RMC Office for Greenville County in Plat Book WWW, Page 3, said lot having a frontage of 100 feet on the southerly side of Heathwood Drive, a depth of 150 feet on the east, a depth of 150 on the west and 100 feet across the rear.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
