The Mortgagor covenants and agrees as follows:

- 1. That he will promptly pay the principal of and interest on the impleteriness evidenced by the said note at the times and in the manner therein provided or as modified at satended by mating agreement in walking.
- 2. That this mortgage shall secure the Mortgages for such further frims as may be advanced hereafter, at the option of the Mortgages, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein, and also any further losins advances, resolvances or credits that may be made hereafter to the Mortgages by the Mortgages, and for any other as further obligation or indebtedness due to the Mortgages by the Mortgager at any time hereafter, and that all sums so advanced shall bear interest at the same rate as the Mortgage debt and shall be payable on demand of the Mortgages, unless otherwise provided in writing, and the lien of this mortgage securing such advances and resolvances shall be superior to the rights of the holder of any intervening lien or encumbrance.
