"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known as Lot No. 99 of a Subdivision known as Hillsborough, Section II, according to a Plat thereof prepared by Jones Engineering and Surveying Company, dated November 1970, and recorded in the RMC Office for Greenville County in Plat Book 4F at Page 51 and fronting on Lanceway Drive

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may at its option apply for mortgage insurance for an additional period of five years with the mortgage insurance company insuring this loan, and the mortgagor agrees to pay to the mortgagee as premium for such insurance one half of 1% of the principal balance then existing.
