

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Mauldin, being Greenville, near the Town of Mauldin, being known and designated as Lot No. 105 on a plat of Section I, Holly Springs Subdivision, prepared by Piedmont Engineers & Architects, being recorded in Plat Book 4N at page 5 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northerly edge of Brook Bend Road, joint front corner of Lots No. 105 and 106 and running thence with the line of Lot No. 106, N. 4-13 E. 150.0 feet to an iron pin; thence N. 86-45 E. 90 feet to an iron pin at the joint rear corner of Lots No. 105 and 104; thence along the line of Lot No. 104 S. 4-35 W. 150.18 feet to an iron pin on the northerly side of Brook Bend Road; thence with the edge of said Road, S. 77-11 W. 39.3 feet; thence continuing with said Road N. 85-47 W. 50.7 feet to an iron pin, being the point of beginning.
