"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, known and designated as Lot 14-B, being a portion of Tract No. 14, Mountain View Acres, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "I" at pages 69 and 70 and having according to said plat and according to a recent plat made by R. W. Dalton, Surveyor, July 6, 1953, the following metes and bounds:

BEGINNING at an iron pin on the Southeast side of Woodland Drive, which iron pin is 429.5 feet in a Southwesterly direction from the southwest intersection of Woodland Drive and Rasor Drive and running thence S. 50-20 E. 194 feet to an iron pin; thence S. 48-45 W. 50 feet to an iron pin; thence N. 56-28 W. 210.8 feet to an iron pin on the southeasterly side of Woodland Drive, thence along the Southeasterly side of Woodland Drive, N. 58-11 E. 75 feet to an iron pin, the point of beginning.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
