EVEN DATE HEREWITH, STAND INDEBTED, FIRMLY HELD AND BOUND UNTO THE CITIZENS AND
SOUTHERN NATIONAL BANK OF SOUTH CAROLINA, Greenville, S. C., HEREINAFTER
CALLED MORTGAGEE, THE SUM OF Seven Thousand Forty Dollars and Forty Cents
DOLLARS (\$ 7,040.40), REPRESENTING \$ 5,000.00 OF PRINCIPAL

Hall Estate, recorded in Plat Book C at Page 234 and described as follows:

BEGINNING at a stake on the southern side of Cook Street at the corner of Lot 27 and running thence with the line of said Lot S. 2-30 W. 84 feet to a stake at corner of Lot 11; thence with the line of Lots 11 and 12 due West 54 feet to a stake at corner of Lot 24; thence with the line of said Lot N. 2-30 E. 84 feet to a stake on Cook Street; thence with the southern side of said street due east 54 feet to the beginning corner.
