

This rider is attached to and made a part of a security instrument executed by the undersigned to the Palmetto Production Credit Association under date of August 23, 1972 37

The aforesaid lands have been surveyed recently by C. O. Riddle, Reg. Land Surveyor, under date of October 19, 1962, and the plat thereof shows the property by courses and distances as follows: BEGINNING at an iron pin in or near the center of Fork Shoals Road, adjoining properties of S. B. Huff and running thence S. 72-26 W. 2298.5 feet along Huff's line to iron pin; thence continuing along Huff's line S. 74-56 W. 2230 feet to an iron pin corner on Huff's land; thence N. 7-17 W. 1568 feet to a white oak corner; thence N. 73-55 E. along lands of W. M. Riddle 1799 feet to iron pin; thence N. 65-40 E. 339 feet to iron pin; thence N. 45-00 W. 810.6 feet to iron pin approximately 25 feet from a dirt road; thence along line of Annie Mae F. Harris S. 85-58 E. 613.1 feet to iron pin; thence S. 85-41 E. 489.4 feet to a stone in a branch; thence following the branch as the line, with the traverse line thereof being N. 59-40-E. 873.5 feet to iron pin; thence N. 87-03 E. 825 feet to corner in or near the center of the Fork Shoals Road; thence along said road S. 23-04 E. 79.9 feet to bend; thence S. 20-21 E. 100 feet to bend; thence S. 17-41 E. 100 feet to bend; thence S. 15-59 E. 100 feet to bend; thence S. 12-50 E. 100 feet to bend; thence S. 11-16 E. 250 feet to another bend; thence continuing along said road S. 10-25 E. 1500 feet to beginning.

The Plat made by C. O. Riddle, Surveyor in October, 1962 referred to above is recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "RR" at Page 113.

Scott corner, and running thence with property now or formerly of Scott S. 23-30 E. 334 feet to an iron pin; thence N. 87-56 E. 852 feet to an iron pin on the Eastern bank of a creek; thence along said creek S. 76-30 E. 33 feet to an iron pin; thence N. 54-50 E. 123 feet to a white oak in the line of property of S. B. Huff; thence with line of property of Huff N. 75-06 E. 903 feet to a stone; thence with property of Huff N. 74-55 E. 1109 feet to an iron pin on the Eastern side of Reedy Fork Creek; thence with said Creek along line of property now or formerly of Riddle and Scott the following courses and distances: N. 48-40 W. 57 feet; N. 23-30 W. 100 feet; N. 13-25 W. 242 feet; thence N. 20-30 E. 130 feet; N. 56-50 W. 48 feet; N. 11-20 W. 127 feet; N. 10-15 E. 65 feet; N. 26-40 W. 500 feet to a point in the center of said creek, joint corner of W. R. Boling and Scott; thence S. 73-35 W. 1107-6 feet to an iron pin; thence S. 80-40 W. 847 feet to an iron pin; thence S. 18-55 E. 105.6 feet to an iron pin; thence S. 73-35 W. 678.5 feet to an iron pin on the bank of a creek; thence following the line of creek N. 76-42 W. 296.7 feet; thence crossing said creek S. 48-50 W. 95.9 feet; thence S. 53-30 W. 98 feet to a sweetgum; thence S. 21-57 E. 198 feet to a point in the middle of a road; thence following said road S. 68-30 E. 113.5 feet to a bend; thence S. 33-30 E. 221.7 feet to a bend; thence S. 49 E. 144.5 feet to a bend; thence S. 39-45 W. 205.9 feet to a point in the center of said road, point of beginning. Plat of property by C. O. Riddle above referred to is recorded in Plat Book II, at Page 113, in the R. M. C. Office for Greenville, South Carolina.

Reference is also made to that certain plat prepared by Harold Hawkins, Surveyor, of Seneca, South Carolina dated July 1, 1965, entitled "property of FCX Corporative Service, Inc." showing the aforesaid property upon resurvey to contain 76.68 acres, more or less.
