Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinafter described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided, or as modified or extended by another agreement in writing.

2. That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein, and also any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee; and that all sums so advanced shall bear interest at the same rate as the Mortgage debt and shall be payable on demand of the Mortgagee, unless otherwise provided in writing.

3. That he will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and other hazards, in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that he does hereby assign to the Mortgagee all such policies, and that all such policies and renewals thereof shall be held by the Mortgagee and have attached thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee.

4. That he will keep all improvements now existing or hereafter erected upon the mortgaged property in good repair, and, in the case of a construction loan, that he will continue construction until completion without interruption, and should he fail to do so, the Mortgagee may, at its option, enter upon said premises, make whatever repairs are necessary, including the completion of any construction work underway, and charge the expenses for such repairs or the completion of such construction to the mortgage debt.

5. That the Mortgagee may require the maker co-maker or endorser of any indebte liness so cured hereby to carry life insurance upon himself in a sum sufficient to pay all sums socied by this mortgage designating the Mortgagee as beneficiary thereof and apon failure of the Mortgager to pay the premiums therfor, the Mortgagee may, at its option, pay and premiums, and all sums so advanced by the Mortgagee shall become a part of mortgage delt.

6. That, together with, and in addition to, the monthly payments of principal and interest pay able under the terms of the note secured hereby, he will, at the action of the Martyagee pay to the Mortgagee, on the first day of each month, until the indebte new secured hereby is paid in full a sum equal to one-twelfth of the annual taxes, public assessments as a summance premiums as estimated by the Mortgagee, and, on the failure of the Mortgage a topics a taxes, insurance premiums and public assessments, the Mortgagee may at its option—pay and items and charge all advances therefor to the mortgage debt

7. That he hereby assigns all the rents, issues, and profits of the mortalized premises from and after any default hereunder, and should legal proceeding a to the deal pursuant to this retrument, then the Mortgagee shall have the right to have a receiver appeared of the rests as a and profits, who, after deducting all charges and expenses afterdays such proceedings and execution of his trust as receiver, shall apply the residue of the rents assess of interfers toward the payment of the debt secured hereby.

8 That, at the option of the Mortgagee, this Mortgage shall become due and payable forthwith if the Mortgagor shall convey away said mortgaged premises, or if the title shall become vested in any other person in any manner whatsoever other than by death of the Mortgagor. If Association elects not to declare balance due and payable, Mortgagor is required to furnish Association details of sale and pay it a record transfer fee of 1% of balance or \$25.00, whichever is greater

9. That, in the case of a construction loan, this mortgage shall, at the option of the Mortgagee become due and payable forthwith if the Mortgagor shall permit work on the project to become and remain interrupted for a period of fifteen (15) days without the written consent of the Mortgagee

10. It is agreed that the Mortgagor shall hold and enjoy the precises above conveyed until their is a default under this mortgage or in the note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of this mortgage, and of the note secured hereby, that then this mortgage shall be utterly null and void other
