"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northerly side of Merrifield Court near the City of Greenville, S. C., being known and designated as Lot No. 93 on plat entitled "Final Plat Revised, Map # 1, Foxcroft, Section II" as recorded in the RMC Office for Greenville County, S. C. in Plat Book 4N, pages 36 and 37 and having according to said plat the following metes and bounds, to-wit:
