

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about two miles west from the city of Greenville, being a part of Lot No. 17 conveyed to John K. Temple, Jr. by Lois Earle and India Pepper by deed dated August 10, 1954 according to a survey and plat made by C. C. Jones on May 13, 1954 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at the intersection of Gordon Street and Curtis Road and running thence with the south side of Gordon Street, N. 79-45 E. 174 feet to a pin on the southern side of Gordon Street, the nce S. 10-15 E. 150 feet to a pin, thence S. 43-15 W. 50 feet to a pin on the northern side of Curtis Road, thence with Curtis Road, N. 46-59 W. 224 feet to the beginning corner.
