All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the north side of Holly Road, and being shown and designated as Lot No. 7 on Plat of Edwards Forest Heights recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "OOO", at page 89, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin at the joint corner of Lots 6 and 7, and running thence N. 38-07 W., 175 feet to the joint rear corner of said lots; thence N. 51-53 E., 134.7 feet to the joint rear corner of Lots 7 and 8; thence with said lots, S. 27-07 W., 182.1 feet to the joint front corner of said lots on Holly Road; thence with Holly Road, S. 57-19 W., 33 feet to an iron pin; thence continuing along said Road, S. 51-53 W., 67 feet to the point of BEGINNING.
