"ALL that certain place; parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and on the southeastern side of Meece Bridge Road and being shown as the property of John Roberts on a recent survey by Carolina Surveying Company dated March 16, 1972 and recorded in the RMC Office for Greenville County in Plat Book
45 at Page 42, and having, accounding to said plat, the following metes and bounds, to-wit:

Beginning at a point in the center of Meece Bridge Road, common corner of the within described tract and that now or formerly of Moore and running thence N.82-28 E. 1090.3 feet to an Iron pin; thence S.20-20 E. 35. 2 feet to an Iron pin; thence S.24-10 W. 1522.5 feet to an Iron pin; thence N.18-30 W. 343.2 feet to an Iron pin; thence N.89-30 W. 1023.0 feet to a point in the center of Meece Bridge Road; thence with the center line of Meece Bridge Road N.37-04 E. 742.3 feet to a point; thence continuing with the center line of Meece Bridge Road N.33-55 E. 182.6 feet to a point; thence continuing with the center line of Meece Bridge Road N.29-22 E. 230.1 feet to the point of beginning.

The Mortgagor covenants that it is lawfully seized of the premises heirelnabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided berein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
