"ALL that piece, parcel or lot of land located in the County of Greenville, State of South Carolina, situate on the north side of Beck Avenue, and being known and designated as Lot 108 on plat of Augusta Road Ranches, Property of Sarata R. Beck, dated April, 1941, prepared by Dalton & Neves, Engineers, and recorded in the R.M.C. Office for Greenville County, in Plat Book M. at Page 47, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the north side of Beck Avenue at the joint front corner of Lots 107 and 108 and running thence along Beck Avenue N. 89-47 E. 60 feet to a point; thence running N. 0-13 W. 316.9 feet to a point; thence running S. 72-28 W. 62.8 feet to a point; thence running S. 0-13 E. 298.2 feet to the point of beginning.
