

It is hereby agreed, that should any default be made in the payment of interest upon this mortgage and such interest remains unpaid and in arrears for ten days, or should any suit be commenced to foreclose said first mortgage, then the sum(s) secured by this mortgage and the accompanying note shall become due and be due and payable at any time thereafter at the option of the owner or holder of this mortgage.

It is further agreed, generally, that said mortgagor may, at his election, advance and pay all and all sums of money that in his judgment may be necessary to perfect title of said mortgaged premises or to prosecute or defend the action intended to be given by this mortgage to advance and pay any and all installments of principal or interest on any and all prior mortgage held out and all sums of money so advanced and paid shall bear interest at the rate of which was originally contracted for in this instrument, and they hereby are made part of the mortgage debt hereby secured. The mortgagor hereby expressly agrees to pay all and singularly the sum(s) of money together with said interest as aforesaid to be paid by the holder hereof.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises unto the said
Consolidated Credit Corporation of Greenville, South Carolina, Inc., hours and assign forever

AND WE do hereby bind our heirs executors and administrators to procure and execute our further necessary assurances of title to the said premises, the title to which is unencumbered and also to warrant and forever defend all and singular the said Premises unto the said mortgagee.

Consolidated Credit Corporation of Greenville, South Carolina, Inc., and assigns, from and against us and our heirs executors and administrators

and all persons lawfully claiming, or to claim the same or any part thereof.

AND IT IS AGREED by and between the parties hereto, that the said mortgagee, their heirs executors, or administrators, shall keep the buildings erected or to be erected on said premises, insured against loss or damage by fire for the benefit

of the said mortgagee for an amount not less than One Thousand Three Hundred Eighty Dollars and 00/100 Dollars, in such company as shall be approved by the said mortgagee, and shall deliver the policy to the said mortgagee, and in default thereof, the said mortgagee, Consolidated Credit Corporation of Greenville, S.C., may negotiate its right to effect such insurance and reimburse themselves under this mortgage for the expense thereof, with interest thereon from the date of its payment. And it is further agreed, in the event of other insurance and contribution between the owners, that the said mortgagee

or assigns shall be entitled to receive from the aggregate of the insurance money to be paid, a sum equal to the amount of the debt secured by this mortgage.

AND IT IS AGREED by and between the said parties, that if the said mortgagee, their heirs executors, administrators or assigns, shall fail to pay all taxes and assessments upon the said property when the same shall first become payable than the said mortgagee,

or assigns, may cause the same to be paid, together with all penalties and costs incurred thereon, and reimburse themselves under this mortgage for the sum so paid, with interest thereon, from the date of such payment.

AND IT IS AGREED by and between the said parties, that upon any default being made in the payment of the interest on the said Note, or of the insurance premiums, or of the taxes, or of the assessments hereinabove mentioned, when the same shall become due and payable, or in any other of the provisions of this mortgage, that then the entire amount of the debt secured, or intended to be secured hereby, shall forthwith become due, at the option of the said mortgagee. AND IT IS AGREED, That if the holder of the Note secured hereby is compelled to pay any taxes upon the debt represented by said note or by this mortgagee, then, and in that event, unless the said taxes are paid by some party other than the said holder, that then the entire amount of the debt secured, or intended to be secured, shall forthwith become due at the option of the said mortgagee. AND IT IS AGREED by and between the said parties, that, should legal proceedings be instituted for the collection of the debt secured hereby, then and in that event, the said mortgagee, A.B. FORD BALD, or assigns, shall have the right to have a Receiver appointed of the rents and profits of the above described premises, with power to forthwith lease out the said premises now, or to do so, when after deducting all charges and expenses attending such proceedings, and the execution of the said trust as Receiver, shall apply the residue of the said rents and profits towards the payment of the debts secured hereby.
