It is hereby agreed, that should any default be made in the payment of interest on said first mortgage, and such interest remains unpaid and in arreate for ten days, or should any suit be commenced to foreclose said first mortgage, then the amount secured by this mortgage and the accompanying note shall become and be due and payable at any time thereafter at the option of the dwner or holder of this mortgage.

AND we do hereby bind our selves and our beirs, executors and administrators, to procure or execute any further necessary assurances of title to the said premises, the title to which is unencumbered and also to warrant and dorever defend all and singular the said Premises unto the said mortgagee Domestic Loans of Greenville, Inc.,

and assigns, from and against UB and OUT heirs, executors and administrators

and all persons lawfully claiming, or to claim the same or any part thereof.

AND IT IS AGREED, by and between the parties hereto, that the said mortgagor their heirs, executors, or administrators, shall keep the buildings crected, or to be erected on said premises, insured against loss or damage by fire, for the benefit (\$7,584,00) of the said mortgagee, for an amount not less than 8600 thousand five hundred eighty four and no/100 Dollars, in such company as shall be approved by the said mortgagee, and shall deliver the policy to the said mortgagee, and in default thereof,

the said mortgagee Domestic Laons of Greenville, Inc., their successors or assigns, maye effect such insurance and reimburse themselves under this mortgage for the expense thereof, with interest thereon, from the date of its payment. And it is further agreed, in the event of other insurance and contribution between the insurers, that the said inortgagee

Domestic Laons of Greenville, Inc., their successors or assigns shall be entitled to receive from the aggregate of the insurance moneys to be paid, a sum equal to the amount of the debt secured by this mortgage.

AND IT IS AGREED, by and between the said parties, that if the said mortgagor, their heirs, executors, administrators or assigns, shall fall to pay all taxes and assessments upon the said premises when the same shall first become payable, then the said mortgagee, Domostic, Loans of Greenville, Inc., their successors or assigns, may cause the same to be paid, together with all penalties and costs theured thereon, and reimburse themselves under this mortgage for the sums so paid, with interest thereon, from the dates of such payments.

AND IT IS AGREED, by and between the said parties, that, should legal proceedings be instituted for the collection of the debt secured hereby, then and in that event, the said mortgaged.
