All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Ladbroke Court, being known and designated as Lot No. 381, as shown on a Plat of De's Norte Estates, Section No. III, made by Piedmont Engineers & Architects, recorded in the R. M. C. Office for Greenville County, in Plat Book 4-N, at Page 14, and having, according to said Plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of Ladbroke Court, at the joint front corner of Lots 380 and 381, and running thence with the common line of said Lots S. 20-32 E. 133.7 feet to an iron pin; thence running 5. 74-53 W. 200.0 feet to an iron pin at the joint rear corner of Lots 381 and 382; thence with the common line of said Lots N. 29-45 E. 203.8 feet to an iron pin on the southern side of Ladbroke Court; thence with the line of said Ladbroke Court N. 89-21 E. 45.0 feet to the point of beginning.
