ALL that piece, parcel or lot of land, together with buildings and improvements thereon or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, near the City of Greenville, on the Easterly side of Crestwood Drive, and having according to recent survey thereof entitled "Survey for Geraldine P. Crane", made by Piedmont Engineers and Architects, dated January 29, 1973, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Crestwood Drive at the Northern corner of property now owned by Geraldine Par Crane, and running thence along the Easterly side of Crestwood Drive, N. 27-30 E., 155 feet to an iron pin; thence around a curve, the chord of which is N. 72-30 E., 35.3 feet to an iron pin; thence along the line of other property of Mortgages. 62-30 E., 175 feet to a point; thence along the line of other property of Mortgagee, S. 27-30 W., 180 feet to an iron pin, rear Easterly corner of property now owned by Geraldine P.
