ALL those certain lots or land situate in Fairview Township, County of Greenville, State of South Carolina, running on a cut cut road and known as Lots 21 and 20, in accordance with Plat made for Mary E. Leake by Webb Surveying and Mapping Company, dated November 1, 1962, and being more Fully described in accordance with said Plat, to-wit:

BEGINNING at an iron pin on the Southern side of said new cut road, joint front corner of Lots 19 and 20, and said point being 133.5 ft. from the intersection of new cut road and Bryson Drive and running thence along Lot 19, S. 28-30 W., 150 ft. to an iron pin; thence N. 64-47 W., 160 ft. to an iron pin; thence N. 28-30 E., 150 ft. to an iron pin on the edge of new cut road; thence along said road, S. 64-47 E., 160 ft. to an iron pin being the point of beginning.
