proof, of one over the other; it is understood and NOTICE a hereby given it has not unity, that any note secured by the mortgage shall be used as evidence of a primary indebtedness or as collateral s. curry for other notes and instruments and likewise to secure any notes or other instruments that may be given in renewal, or curtail of said indebtedness, or any part thereof and as such shall serve as NOTICE to any subsequent henor that only the mortgage or the holder of said note or notes may verify the outstanding unpaid balance.

The mortgagor(s) herein do hereby, expressly waive, release and discharge their homestead exemption as allowed by Laws of the State of South Carolina. Said Homestead Exemption is waived, released and discharged until the entire amount owed hereunto is paid in full.

The noteholder hereunder is authorized, for the account of the mortgagor(s), to make any required payments under any lien prior hereto, or under this mortgage, the non-payment of which would constitute a default, including but not limited to principal and/or interest payments, taxes and fire insurance premiums. And the said Mortgagor(s) do hereby assign set over and transfer to the said mortgagee, its successors and assigns, all of the rents, issues and profits of the said mortgaged premises; accruing and falling due from and after the service of a summons issued in action to foreclose this mortgage after default in the conditions hereof.

Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in anywise incident or appertaining. Including but not limited to all buildings, improvements, fixtures, or appurtenances now or hereafter erected thereon, including all apparatus, equipment, fixtures, or articles whether in single units or centrally controlled, used to supply heat, gas, air conditioning, water, light, power, refrige ation, ventilation or other services, and also together with any screens, window shades, storm doors and window creen doors, awnings, stoves and water heaters (all of which are declared to be a part of said real estate whether physically attached thereto or not).

TO HAVE AND TO HOLD all and singular the said premises unto the said mortgagee, its successors and assigns forever. And the mortgagor(s) do hereby bind their heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said mortgagee, its successors and assigns from and against their heirs, executors, administrators and assigns and all other persons whomsoever lawfully claiming or to claim the same or any part thereof.
