(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:
WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF REENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

onditions), said note to be repaid with interest as the rate or rates therein specified in installments of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgage to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near Pelzer, South Carolina, in Oaklawn Township, on the north side of S. C. Highway No. 8, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin S. 83-03 E. 387 feet from an iron pin in the curvature of the intersection of State Highway # 8 and the old Pelzer Road, and running thence with the north side of said Highway # 8, S. 83-03 E. 190 feet to an iron pin; thence N. 7-0 E. 203.5 feet to an iron pin; thence N. 83-03 W. 190 feet to an iron pin; thence S. 7-0 W. 203.5 feet to an iron pin on the north side of S.
