That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand seel and truly paid by the Mortgagor at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the eastern side of East Woodburn Drive, being shown as lot no. 32 on a plat of Seven Oaks Subdivision, dated May 15, 1972, prepared by C. O. Riddle, recorded in Plat Book 4R at Page 6 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

Woodburn Drive; thence with said Drive N. 21-58 W. 68.9 feet to the point of beginning.
