All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 76 on

plat of Wellington Green as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book YY, at Page 29, and having, according to said plat, the following courses and distances, to-wit:
