TO ALL WHOM THESE PRESENTS MAY CONCERN: JIM WILLIAMS, INC.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith the terms of which are incorporated herein by reference, in the sum of THIRTY-SEVEN THOUSAND AND NO/100 ------

DOLLARS (\$ 37,000.00

), with interest thereon as provided in said promissory note, said prin-

cipal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

All that piece, parcel or lot of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Greenville County, State of South Carolina, being shown and designated as Lot No. 24 on plat of Pilgrim's Point, recorded in Plat Book WWW at Page 35 in the RMC Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwesterly side of Hudson Road which iron pin is the joint corner of Lots 24 and 25; running thence N. 30-24 W. 185.85 feet to an iron pin; thence S. 63-27 W. 85.0 feet to an iron pin; thence S. 1-28 W. 255.0 feet to an iron pin on the Northwesterly side of Hudson Road; thence along the Northwesterly side of Hudson Road N. 53-51 E. 95.9 feet to a point; thence continuing along Hudson Road N. 52-32 E. 125.0 feet to an iron pin, the point of Beginning.
