"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 23A on plat entitled "Sheet I - Huntington", recorded in the RMC Office for Greenville County, South Carolina, in Plat Book WWW, at Page 23B, and having, according to said plat, the following courses and distances, to-wit:
