WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE. S. C., (hereinafter referred to as Mortgagee) in the sum of Forty-Five Thousand, Six Hundred and No/100 (\$45,600,00) ----- DOLLARS

(\$ 45,600.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, being known and designated as Lot No. 33 Timrod Way, Section 2, of Parkins Lake Development near Greenville, S. C., according to a plat thereof made October 22, 1962 by R. K. Campbell, Engineer, and recorded in the R.M.C. Office for Greenville County in Plat Book YY at page 93 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Timrod Way at the joint front corner of Lots Nos. 34 and 33 and running thence with the line of Lot 34, S. 56-08 E. 187.3 feet to an iron pin at the rear line of Lot No. 41; thence with the rear line of Lots Nos. 41 and 42, N. 33-55 E. 160 feet to an iron pin at the joint rear corner of Lots Nos. 32 and 33; running thence with the line of Lot 32, N. 56-05 W. 185 feet to an iron pin at the joint front corner of Lots Nos. 32 and 33; running thence with Timrod Way, S. 33-55 W. 103.8 feet to an iron pin; thence with Timrod Way, S. 33-15 W. 56.2 feet to an iron pin at the beginning corner.
