All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the Western side of Buckingham Road, being shown and designated as Lot No. 216 on a Plat of GOWER ESTATES, SECTION B, made by R. Campbell, R.L.S. dated December 1961, recorded in the RMO Office for Greenville County, South Carolina in Plat Book XX, Pages 36 and 37 and having according to said Plat the following metes and bounds, to-wit:
