(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hercinafter referred to as Mortgagee) in the sum of Thirty-Three Thousand Seven Hundred Fifty and No/100ths------DOLLARS

(\$ 33,750.00 .), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual coasent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Oakway Circle, being shown and designated as Lot \$4 on Plat of Oakway Subdivision, prepared by Carolina Engineering and Surveying Company, dated December 28, 1965 and recorded in the REC Office of the Greenville County Courthouse in Plat Book JJJ at page 107 and being described, according to said Plat, more particularly, to-vit:

BEGINNING at an iron pin on the Southern side of Oakway Circle at the joint front corner of Lots 4 and 5 and running thence with the common line of said Lots S. 7-32 E. 216.6 feet to an iron pin; thence along the rear line of Lot #4 S. 80-54 W. 210 feet to an iron pin at the joint rear corner of Lots 3 and 4; thence along the common line of said Lots N. 9-06 W. 210 feet to an iron pin at the joint front corner of said Lots on the Southern side of Oakway Circle; thence along Oakway Circle N. 80-54 E. 192 feet to an iron pin; thence along a cul-de-sac of said Circle, the cord of which is N. 65-51 E., 25 feet to an iron pin, the point of beginning.

The above-described property was conveyed to the Mortgagor by Deed recorded in the RMC Office of the Greenville County Courthouse in Deed Book 979 at page 559.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgager promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgager's amount and collect it as part of the debt secured by the nortgage.

The mortgagors agree that after the expiration of ten years from the date hereof, the mortgagee may at its option apply for mortgage insurance for Together with all end singular the rights, members, hereditaments, and appartenances to the same belonging or in any way incident or appendicing and all of the rents, issues, and profits which may arise or be had therefrom, and including all leading, phenology and lighting fixtures and any order configurate or fixtures now or hereafter attached, connected, or fitted the reto in any memory, it belong the intention of the paties hereto that all such fix tures and equipment, other than the usual handchold functions, be considered a port of the real estate.
