WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the physical thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 327 on plat of Del Norte Estates, Section II, recorded in Plat Book 4-N at pages 12 and 13 in the R.M.C. Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Scottswood Drive at the joint front corner of Lots 328 and 329 and running thence along and with the joint property line of said two Lots, S 60-16 W 135.95 feet to an iron pin at the joint rear corner of said Lots; thence along the rear line of Lot 327, N 31-58 W 72.65 feet to an iron pin; thence N 23-28 W 40.0 feet to an iron pin on the southern side of Del Norte Road; thence running along and with the southern side of Del Norte Road N 55-01 E 59.6 feet to an iron pin; thence continuing with said Road, N 62-30 E 50.0 feet to an iron pin; thence S 73-37 E 36.0 feet to an iron pin on the western side of Scottswood Drive; thence along said Drive, S 29-44 E 90.0 feet to an iron pin, the point of beginning.
