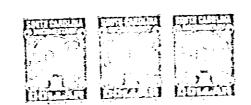

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$1.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Paris Mountain Township, being known and designated as Lot No. 7 of a subdivision known as Sans Souci Heights No. 1 as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book HH at page 25 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the southwest corner of the intersection of Merrilat Avenue and U. S. Highway No. 25 (also known as the New Buncombe Road), and running thence along the southwest side of said U. S. Highway No. 25, N. 39-10 W. 77 feet to an iron pin; thence S. 50-50 W. 150 feet to an iron pin in line of Lot No. 52; thence along the line of Lots Nos. 52 and 53, S. 39-10 E. 12 feet to an iron pin; thence N. 50-50 E. 12 feet to an iron pin; thence S. 39-10 E. 65 feet to an iron pin on the west side of Merrilat Avenue; thence along the west side of Merrilat Avenue, N. 50-50 E. 138 feet to the beginning corner.

The above described lot is composed of the greater portion of Lot No. 7 and a 12-foot strip of Lot No. 8 as first laid out on plat recorded in the R.M.C. Office for Greenville County in Plat Book W at page 155 and is the same property conveyed to me by Richard F. Collins by deed dated February 24, 1955, recorded in Deed Vol. 519 at Page 305.
