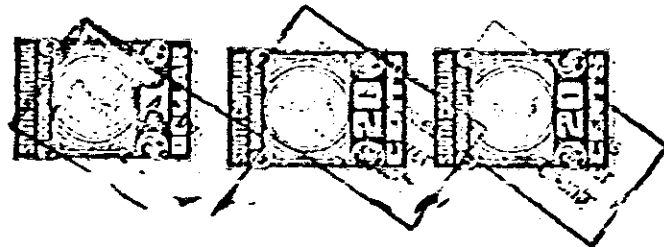
WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, in or near the Town of Piedmont, and being more particularly described as Lot No. 47, Section 4, as shown on a plat entitled "Property of Piedmont Mfg. Co., Greenville County", made by Dalton & Neves, February, 1950; Sections 3 and 4 of said plat are recorded in the RMC Office for Greenville County in Plat Book Y at pages 2-5, inclusive, and pages 6-9, inclusive, respectively. According to said plat, the within described lot is also known as No. 21 Hammett Street (Avenue) and fronts thereon 110 feet.
