**MORTGAGE** 

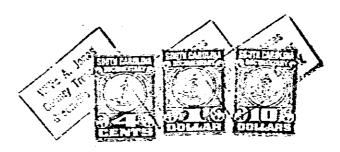
THIS MORTGAGE is made this 4th day of September , 19 73 between the Mortgagor, HERBERT J. ROBINSON AND CONNIE P. ROBINSON

(herein "Borrower"), and the Mortgagee, Security Federal Savings and Loan Association a corporation organized and existing under the laws of the State of South Carolina, whose address is E. Camperdown Way, Greenville, S. C. 29601 (hereir 'Lender').

WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty Seven Thousand Six Hundred (\$27,600.00)Dollars, which indebtedness is evidenced by Borrower's note of even date herewith (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on November 10, 1998

ALL that certain piece, parcel or lot of land, situate, lying and being on the Northwestern side of Whitestone Avenue, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 24 as shown on plat entitled ADAMS MILL ESTATES, dated July, 1972, prepared by Dalton & Neves Co., Engineers and recorded in the RMC Office for Greenville County, S. C., in Plat Book 4R, Page 31, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Whitestone Avenue and running thence N. 40-56 W. 174.2 feet to an iron pin; thence N. 25-47 E. 60 feet to an iron pin at the joint rear corner of Lots Nos. 23 and 24; thence with the line of Lot No. 23, S. 64-13 E. 160.04 feet to an iron pin on the Northwestern side of Whitestone Avenue at the joint front corner of Lots Nos. 23 and 24; thence along the Northwestern side of Whitestone Avenue, S. 25-47 W. 128.9 feet to the point of beginning.



To Have and to Hold unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate in the event this Mortgage is on a leasehold) are berein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any easements and restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.

Uniform Covenants. Borrower and Lender covenant and agree as follows:

1. Poyment of Principal and Interest. Borrower shall promptly pay when due the principal of and interest on the indebtedness evidenced by the Note, prepayment and late charges as provided in the Note, and the principal of and interest on any Future Advances secured by this Morresage.
