All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, hing and being in the State of South Carolina, County of Greenville, being known and designated as Lot Number 16 Annissa Acres, as shown on plat entitled Annissa Acres, prepared by Jones Engineering Company, recorded in Plat Book 4-R at Page 63 in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to-wit:


