- (3) That the covenants herein contained shall bind, and the benefits and advantages shall inure to, the respective helrs, executors, administrators, successors and assigns, of the parties herets. Whenever used, the singular shall included the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
