## MORTGAGE OF REAL ESTATE

WHEREAS: ALFRED W. MITCHELL AND NAOMI R. MITCHELL OF Greenville, S. C. hereinafter

, hereinafter called the mortgagor(s) is indebted to Cameron-Brown Company, a corporation organized and existing under the laws of the State of North Carolina, hereinafter called mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of ONE THOUSAND SIX HUNDRED EIGHTY-THREE AND 37/100THS----(\$ 1,683.37) Dollars, together with add-on interest at the rate of 5-3/4 (%) per cent per annum, until paid in full, said principal and interest being payable at the office of Cameron-Brown Company in Raleigh, North Carolina, or at such place as the holder of the note may designate in writing delivered or mailed to the mortgagor(s), in monthly installments of Thirty-six and 18/100ths---- (\$ 36.13 ) Dollars, commencing on the , 19  $7^a$  , and continuing on the fifteenth fifteenth day of February day of each month thereafter for 59 months, with a final payment of (\$35.67principal and interest are fully paid, provided, however, that if not sooner paid the entire indebtedness shall be due and payable on the fifteenth day of January 19 79; the mortgagor(s) shall have the right to prepay or anticipate payment of this debt in whole or in part at anytime, in amounts not less than the aforesaid monthly installments, and shall receive a rebate for any charged-but-unearned interest, computed in accordance with the Standard Rule of 78.
