

That the Mortgagor, in consideration of the aforesail debt, and in order to secure the payment thereof, and of any other and further smas for which the Mortgagor may remarked to the Mortgagor, and also in consideration of the further smaller Dollars \$50.00 to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling and delivery of these presents, the receipt whereof is hereby and a well-granted, bargained, sold and released, and by these presents does grant, i arguin self-and release unto the Mortgagor, its supersons and assigns:

"ALL that certain piece, pared or let of bank which all is prevenents thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being Lot 1, White Horse Road Extn. as shown on plat of property of John Flynn, as recorded in Plat Book NNN at page 51, in the R.M.C. Office for Greenville County, South Carolina and being the same property conveyed to the mortgagor by deed recorded in deed book 913 at page 465, reference to which is hereby craved for a more complete description thereof.

ALSO all that certain piece, parcel or lot of land situate lying and being in the County of Greenville, State of South Carolina, and being the western portion of that certain lot shown of Plat of Property of Dempsey Window Company, Inc., as recorded in Plat Book ZZ at page 109, and lying on the Southeast corner of the intersection of White Horse Road Extension and Lucille Avenue, and being the same property conveyed to the mortgagor hereing by deed recorded in deed book 974 at page 151, reference to which is hereby craved for a more complete description thereof.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagor forever, from and against the Mortgagor and all persons whomsoever I whilly claiming the same or any part thereof.
