To All Whom These Presents May Concern:

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Two Hundred Three

) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said helder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes insurance premiums, repairs, or for any other purpose:

NOW KNOW ALL MEN. That the Mortzagor, in consideration of said debt and to score the payment thereof and any further sums which may be advanced by the Mortzagoe to the Mortzagor's account, and also in consideration of the sum of Three Dollars (53:00) to the Mortzagor in head well and truly paid by the Mortzagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe its successors and assigns, the following described real estate.

All that certain piece, parcel, or let of land, with all improvements thereon, or hereafter to be constructed thereon, situate, bing and being is the State of South Carolina. County of Greenville, on the southeasterly side of Gilder Creek Drive, in the City of Mauldin, S. C., and being designated as Lot No.156 on plat entitled "Forrester Woods, Section 3" as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4R, page 51 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Gilder Creek Drive, joint corner of Lots 156 and 157 and running thence along the line of Lot 157 and beyond S 45-03 E 150 feet to an iron pin; thence S 35-37 W 160 feet, more or less, to an iron pin; thence N 05-03 W 100 feet to an iron pin, corner of Gilder Creek Drive; thence around said corner on a curve, the chord of which is N 9-19 W 40.3 feet to an iron pin on the southeasterly side of Gilder Creek Drive; thence along said Drive N 27-04 E 101.2 feet to an iron pin, the point of beginning.
