MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Jerry W. Odom, of Greenville County

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHERFAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as a portion of Lots 8 and 9 of Block E of a subdivision known as Mayfair Estates according to plat thereof prepared May 1948 and recorded in the R. M. C. Office for Greenville County in Plat Book S at Pages 72 and 73 and is more fully shown on plat of Property of Jack Shaw prepared June 1974 by C. C. Jones, C. E., recorded in the R. M. C. Office for Greenville County in Plat Book GGG at Page 176 and having, according to said latter plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Tiffany Drive, which iron pin is located 66.5 feet, S. 64-04 W. from the joint front corner of Lots 6 and 7 and running thence along a line through Lot 8, S. 21-56 E. 175 feet to an iron pin, which iron pin is located 66.5 feet, S. 68-04 W. from the joint rear corner of Lots 6 and 7; running thence along a portion of rear line of Lots 8 and 9, S. 68-04 W. 66.5 feet to an iron pin in the rear line of Lot 9; running thence N. 21-56 W. 175 feet to an iron pin on the southern side of Tiffany Drive, which iron pin is located N. 68-04 E. 67 feet from the joint front corner of Lots 10 and 11; running thence with the southern side of Tiffany Drive, N. 68-04 E. 66.5 feet to the point of beginning;
