"ALL that cortain piece, percel or lot of land, with all Improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Floyd Street, being known and designated as Lot 91 on plat of Section 2, Monaghan Subdivision, recorded in Plat Book GG, at Page 151, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Floyd Street to the joint front corner of Lots 90 and 91, and running thence with Lot No. 90, S. 38-30 W. 160 feet to a pin; thence with the rear line of Lot No. 63, N. 51-30 W. 75 feet to corner of Lot No. 92; thence with Lot No. 92, N. 38-30 E. 160 feet to a pin on the southwestern side of Floyd Street; thence with Floyd Street S. 51-30 E. 75 feet to the point of beginning.
