MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

Thomas C. Watkins and Sandra T. Watkins

(hereinafter referred to as Mortgagor) (SEND(S) CREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagoe) in the full and just sum of

Twenty-Seven Thousand Five Hundred and Ho/100------ (\$27,500.00 ...)

Dollars, as exidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be reguld with interest as the rate or rates therein specified in installments of Two Hundred Twenty-

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be grast due and suspoid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Monteague, or any stapidations set out in this monteague, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and parallel and said holder shall have the right to motivate any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

All that certain piece, parcel, or led of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of East Georgia Road (S. C. Highway No. 143) and being known and designated as Lot No. 29 of KINGSWOOD Subdivision, plat of which is recorded in the RMC Office for Greenville County in Plat Book 4-X at Page 18 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of East Georgia Road, joint front corner of Lots 28 and 29 and running thence with the common line of said Lots, S.31-16 W. 332.8 feet to an iron pin; thence N.64-46 W. 167.4 feet to an iron pin on the eastern side of Kingswood Circle; thence with said Circle, N.30-06 E. 300 feet to an iron pin on the southern corner of the intersection of Kingswood Circle and East Georgia Road; thence with the curve of said intersection, the chord being N.71-29 E. 37.5 feet to an iron pin on the southern side of East Georgia Road; thence with said Road, S.67-07 E. 150 feet to the point of beginning.
