BEGINNING at an iron pin on the southwest side of Marchant Street 259.8 feet east from Parker Road at the corner of Lot #6 and running thence with the line of said lot, S. 25-52 E. 158.8 feet to an iron pin on northern side of S. C. By-Pass 253; thence with the curve of the right of way of said By-Pass, the chord of which is N. 50-00 E. 72.9 feet to an iron pin at the corner of Lot #8; thence with the line of said lot, N. 18-13 W. 136.9 feet to an iron pin on Marchant Street; thence with the curve of the southern side of said street, the chord of which is S. 67-55 W. 88.6 feet to the beginning corner.
