MORTGAGE OF REAL ESTATE

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, containing 1.9 acres, more or less, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the edge of Parkins Mill Road and running along said road, S. 83-05 W. 168.4 feet to an iron pin on said road; thence along said road, S. 85 W. 116.3 feet to an iron pin on Parkins Mill Road; thence N. 25-55 E. 398.6 feet to a point on an unnamed street; thence along said street, N. 56-50 E. 80 feet to an iron pin on said street; thence S. 55 E. 154.3 feet to an iron pin; thence S. 16 W. 293.7 feet to the point of beginning.
