"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of East Mountainview Avenue (formerly known as Tremont Avenue), in the City of Greenville, being shown as Lot 109 on plat of North Hills, made by R. E. Dalton, Surveyor, April 1925, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "H", at page 138, and having according to said plat and a recent survey made by R. W. Dalton, Surveyor, December 1, 1954, the following metes and bounds, to-wit:

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
