NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville in the second ward of the City of Greenville and having the following metes and bounds; to-wit:

BEGINNING at a stake on the west side of Vannoy Street, Bates corner and running thence with said Bates line N. 77° W., 52 Feet 8 inches to an iron pin; thence S. 60° E, 50 feet to an iron pin on Vannoy Street; thence with said street N. 33° 29 feet E. 10 ft. to the beginning corner.

ALSO: ALL that lot or parcel of land situate on the west side of Vannoy Street, in the City of Greenville, County of Greenville and State of South Carolina and designated as Lot "A" on plat as made by F. G. Rogers, Engr. and recorded in Plat Book "A", page 421 in the RMC Office for Greenville County and having the following metes and bounds, to-wit:

Commencing at an iron pin on the west side of Vannoy Street, 182 feet - north of the corner of Park Avenue, and running thence with Vannoy Street, N. 33-29 E. 58' 8½" to an iron pin; thence N. 80 W. 162 feet to an iron pin; thence S. 31 W 51'6" to an iron pin; thence S. 77-E. for 157 feet to the beginning corner.
