"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the western side of Meese Bridge Road, containing 8.0 acres, more or less, according to a plat thereof entitled "Property of Boyd T. Hall and Barbara L. Hall" dated September 9, 1972, prepared by C. O. Riddle, Reg. L. S., and having, according to said plat, the following metes and bounds, to-wit:

BBGINNING on a railroad spike in Meese Bridge Road, and running thence N. 73-16 W. 714.4 feet to an old iron pin in the line of property now or formerly of Manly Jones; thence with the line of property now or formerly of Manly Jones, N. 9-32 W. 291.5 feet to an iron pin; thence with the line of property of Crawford H. Rainey and Blba Rainey N. 81-30 B. 817.7 feet to a nail and cap in the center of Meese Bridge Road; thence down Meese Bridge Road S. 3-00 B. 219 feet to a point; thence continuing with Meese Bridge Road S. 12-30 W. 404.4 feet to the point of beginning.
