That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the northern side of Laurens Road, being a portion of the property shown on plat of Property of M. V. Haas made by T. H. Walker, Jr., RLS #3182, dated October 23, 1972, and and having the following metes and bounds, to-wit:

BEGINNING at a point on the eastern side of Rector Avenue, said point being 149.9 feet northeast from the intersection of Rector Avenue and Laurens Road; thence with said Rector Avenue N. 31-34 E. 150.7 feet to a nail and cap located on the northeastern corner of the intersection of Rector Avenue with Paine Street Extension; thence turning and running with said Paine Street Extension S. 56-08 E. 161.3 feet to an old iron pin; thence turning and running S. 33-52 W. 99.9 feet to a point; thence turning and running N. 56-05 W. 84.1 feet to a point; thence turning and running S. 32-37 W. 50.1 feet to a point; thence turning and running N. 56-08 W. 72.25 feet to the beginning point on Rector Avenue.
