"ALL that certain piece; parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

BEING shown and designated as Lot 11 on Plat of Talmer Cordell Property, Map #4, made by Dalton & Neeves, November, 1949, recorded in the RMC Office for Greenville County, South Carolin a, in Plat Book X, at Page 55, reference to said plat being craved for a complete and detailed description thereof. Said lot fronts 58.0 feet on the southwestern side of Maryland Avenue; runs to a depth of 150.0 feet in parallel lines and is 58.0 feet across the rear.
